This concept was first introduced in Ethiopia by the Civil

version only refers to married man.

This text repealed Labour Proclamation No. 42/1993 (as
amended by Proclamation 88/1994). It has become the principal
source of labour law in Ethiopia. So far the Committee of Experts
has not published its comments on the new law. The new statute
