Material Review Board (MRB) – A board consisting of authorized Supplier Quality and Engineering members necessary to review, evaluate and determine the proper disposition of nonconforming material referred to it. When and Why MRB Required? It is a system of recorded investigative checks done on failed components or processes to improve quality.

When a Supplier's Independent MRB privilege is revoked or the Supplier decides to no longer maintain the MRB privilege, the Supplier shall process nonconforming material in accordance with QOS 0035, Supplier Material Review Report (SMRR) located in the OASIS website <https://oasis.northgrum.com> and for project ID's see SQAR (Supplier Quality Assurance Requirements) document SG- 0140 also located in OASIS.
