Until 1813 open carry and concealed carry of a firearm for self defense was accepted by all states. This changed in 1813 when Louisiana and Kentucky banned concealed carry on the grounds that only a criminal would conceal a firearm. Five more states, Alabama, Indiana, Ohio, Tennessee and Virginia enacted similar concealed carry bans by 1859.
